The directors of the San Saba Central Appraisal District met for a regular meeting, Wednesday, May 15, at 8:00 a.m. at the Appraisal District office.

James Lebow, Chairman, called the meeting to order at 7:57 a.m.. Board members, Marcus Amthor and Ray Clark were present. Jake Lackey and Anne Brownlee were absent. Also present was Chief Appraiser, Trish Turner and Financial Officer, Colleen Womack.

Ray Clark gave the invocation and led the board in the pledges of allegiance.

James Lebow, chairman, opened the floor to those desiring to appear before the board. There were none.
